**BUILDING AND ZONING - Theodore L. Horne**

Building Reports - Trustee Horne reported that 7 building permits had been issued between November 17 through December 14, 1997. These include 2 single family residences, 1 residential addition and alteration, 1 storage building, 1 horse barn addition, 1 horse barn demolition, and 1 inground swimming pool. There were 62 inspections completed, and 1 meeting was attended during this time period.

ZBA Report - Trustee Horne deferred to Mr. Kosin to report on the ZBA meeting. Mr. Kosin reported that Chief Danley of the Barrington Countryside Fire Protection District had made a presentation on sprinkling systems. The subjects of sprinkler systems, refuse dumpsters, and lighting were continued to the next meeting.

**HEALTH, ENVIRONMENT AND INSURANCE - Lorraine H. Briggs**

Solid Waste Management - Trustee Briggs reported that she had received a recycling report from Browning Ferris Industries for the month of October, 1997. The report shows that we have diverted 10 1/2% of overall waste from landfills compared to 8 1/2% in October, 1996.
